You are responsible for picking up after the animals in your care. It is expressly understood that every dog at this test/trial is in the care, custody, and control of its owner or handler during the entire time the dog is on the trial premises. BCKC is not responsible for the loss of, damage to, or death of any dog exhibited, or the possessions of any participant, whether the result of accident or any other cause.

#### EXHIBITOR INFORMATION

1. All dogs nine (9) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration are eligible to participate.
2. Dogs should be physically sound. Dogs that are lame, blind, or deaf or have open sores shall not be eligible. No dog shall compete if it is bandaged, stitched or in any way has anything attached to it for medical purposes. If course conditions warrant, protective footwear may be worn if approved by the Judge.
3. At the handler's option dogs may wear flat buckle collars, snap collars, or slip collars, but there shall be no hanging tags or attachments. Pinch collars, electric and dummy electric collars are prohibited. Prong and electric collars (live or dummy) are prohibited on the grounds. Food and toys are not permitted in the course area. 4. *Farm Dog Certification and AKC Herding Regulations* are available from the American Kennel Club, 5580 Centerview Drive, Suite 200, Raleigh, NC 27606-3390. Exhibitors are expected to be familiar with the rules and regulations.

#### Farm Dog Test GENERAL ENTRY INFORMATION

**(ENTRIES WILL BE LIMITED TO 25 DOGS per test. Day of entries will be limited to availability)**

**Entry Fees:** Fee is \$25.00 per entry (includes \$3.50 AKC recording fee). Make all checks and money orders payable to **Burlington County Kennel Club**. No Entries shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance. DAY OF ENTRY IS \$30.

Post-Dated Checks and Returned Checks do not constitute a valid entry fee. The Trial Secretary will add a collection fee of \$30.00 to each returned check.

Exhibitors are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing of entries.

Proof of current rabies vaccination must be furnished upon request.

For entries received same time/same date, trial entries shall receive preference.

**A \$5.00 processing fee per dog will be deducted for ANY refunds.** *Declining Entries: **Burlington County Kennel Club** may decline any entries or may remove any dog from its event for cause, but in each such instance shall file for good and sufficient reasons for doing so with the American Kennel Club.*
